



Rules & Regulations

Only 152,000 tickets will be printed.

GENERAL RULES

Only ONE method of payment will be accepted.

Only ONE mailing address will be recorded.

Hospital Home Lottery tickets, 50/50 Add-On tickets and 100 Days of Winning Cash Calendar Add-On tickets will be mailed separately.

Persons must be 18 years of age to purchase a ticket and the name of a person under 18 years of age may not be written on the ticket.

Only tickets that have been paid for, and verified as paid for, are eligible for the respective draw(s). All inquiries regarding the chances of winning and method of awarding prizes can be made to the licensee at 1-403-691-8097.

The following, including their spouse and any related or dependent person residing in the same household, are prohibited from purchasing a ticket: Calgary Health Trust employees, Board members and Development Council members, the raffle manager and their employees, and the partners and employees of the professional services firm of KPMG LLP.

Tickets may only be sold and purchased within Alberta. Restrictions apply. If your ticket contains an error, please call 1-403-691-8097.

All ticket purchases are final, and refunds are not available. 5,160 prizes will be awarded. All prizes awarded are new product. Prizes awarded may not be exactly as illustrated.

◆ Each Hospital Home Lottery ticket in a 3-pack, 5-pack or 8-pack, each 50/50 Add-On ticket in a 5-pack or 15-pack, and each 100 Days of Winning Cash Calendar Add-On ticket in a 3-pack or 6-pack and Max Pack tickets must contain the same name and contact information. Prizes must be accepted as awarded.

Retail values are approximate as of date contracts were negotiated with suppliers. Due to housing market fluctuations, the market value of the real estate prizes may rise or diminish

over time. Winner or charity is not entitled to the difference, if any, between the stated and actual market value at the time the prize is awarded. Prize values include taxes and freight, where applicable.

100 DAYS OF WINNING™ CASH CALENDAR® ADD-ON RULES

Only 107,010 100 Days of Winning Cash Calendar Add-On tickets are available. Prizes: There will be 1 cash prize of \$50,000 on June 13, 2019 and 100 daily cash prizes of \$3,000 from June 13, 2019 to September 20, 2019. The 100 Days of Winning Cash Calendar Add-On is advertised in conjunction with the Hospital Home Lottery, therefore the ticket sales deadline is May 3, 2019. The 100 Days of Winning Cash Calendar Add-On draws will be held May 15, 2019, commencing at 8:30 a.m. at the offices of KPMG LLP. All draws will be completed in sequence on May 15, 2019. Draws will proceed in order of the 2019 calendar. There will be 1 cash prize of \$50,000 on June 13, 2019, and 100 daily cash prizes of \$3,000 from June 13, 2018 until September 20, 2019. Total prize value of \$350,000. The 100 Days of Winning Cash Calendar Add-On ticket sales deadline is May 3, 2019. Winners will be notified in writing and posted daily on the lottery website at FoothillsHospitalHomeLottery.com beginning June 13, 2019. After each prize draw, the winner is recorded, and the ticket number goes back for the next draw.

DRAW ORDER

The first draw will be for the VIP Prize, the second draw will be for the Bonus Prize, and the third draw will be for the Early Bird Prize. Thereafter, draws are made in order of ascending retail value.

After each draw, including the VIP, Bonus and Early Bird draws, the winner is recorded, and the ticket number goes back in the draw drum for the next draw. Each ticket purchased before the VIP deadline will be eligible for all 5,160 draws. Tickets purchased after the VIP deadline but before the Bonus deadline will be eligible for 5,159 draws. Tickets purchased after the Bonus deadline but before the Early Bird deadline will be eligible for 5,158 draws. Tickets purchased after the Early Bird deadline will be eligible for the remaining 5,157 draws.
